The 1 (one) position advertised here is of State Program Manager, for Pradhan Mantri Awaas Yojana – Gramin. The position is based in Guwahati.

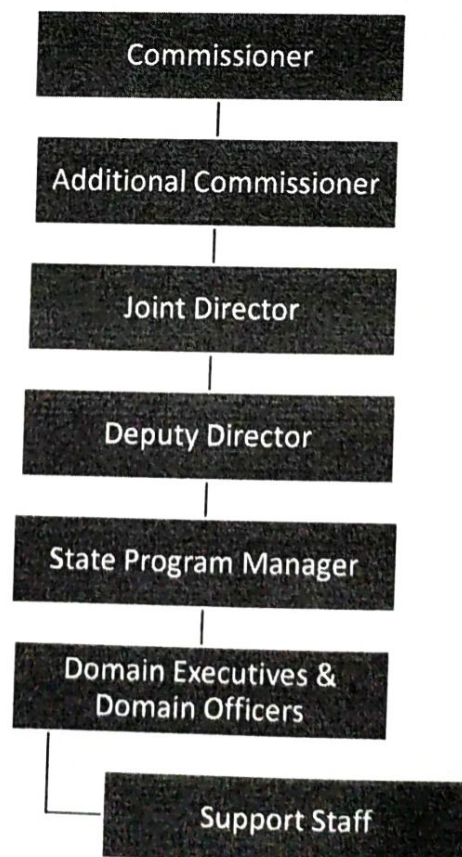
2. Source of Fund
