4. All the expenditure must be incurred in online mode through e-gram swaraj application.
5. All the procedure laid down at AFR condition and codal provisions of AFRBM Act, 2005 and CVC guidelines is to be strictly followed invariably.

2. The admissible deductions can be deducted and deposited into the Govt. Account by the Concerned Authority as per rule/ Govt. Instructions.
3. Work to be completed within the estimated cost in all respect without involving cost and time over run.
4. The amount shall be utilized against the schemes selected by PRIs only as per Govt. of India and Govt. of Assam's guideline .
5. The amount will be distributed to PRIs as per recommendation of FC.
6. The amount shall be drawn by commissioner, Panchayat & Rural Development and shall be disbursed to each of the PRIs in their accounts duly registered under PFMS and the amount shall be transferred through ECS.
7. PRI shall utilize the fund as per Guidelines of 15th FC and shall be responsible for any violation of the guidelines.
8. The overall responsibility for compliance of the guidelines shall continue to rest with the commissioner, Panchayat & Rural Development, Assam
9. UCs should be submitted in prescribed GFR-19A Format in due time.
