#### **ORDER**

- 4. All the expenditure must be incurred in online mode through e-gram swaraj application.
- 5. All the procedure laid down at AFR condition and codal provisions of AFRBM Act, 2005 and CVC guidelines is to be strictly followed invariably.

- 2. The admissible deductions can be deducted and deposited into the Govt. Account by the Concerned Authority as per rule/ Govt. Instructions.
- 3. Work to be completed within the estimated cost in all respect without involving cost and time over run.
- 4. The amount shall be utilized against the schemes selected by PRIs only as per Govt. of India and Govt. of Assam's
- 5. The amount will be distributed to PRIs as per recommendation of FC.
- 6. The amount shall be drawn by commissioner, Panchayat & Rural Development and shall be disbursed to each of the PRIs in their accounts duly registered under PFMS and the amount shall be transferred through ECS.
- 7. PRI shall utilize the fund as per Guidelines of 15th FC and shall be responsible for any violation of the guidelines.
- 8. The overall responsibility for compliance of the guidelines shall continue to rest with the commissioner, Panchayat & Rural Development, Assam
- 9. UCs should be submitted in prescribed GFR-19A Format in due time.
