ORDER

In Pursuance of Govt. in Panchayat & Rural Development Department sanction No.:FS/PRD_2022-23(I)_170, dated 17-01-2023 for **Rs.17.62 Lakhs (Rupees Seventeen Lakhs and Sixty two Thousand only)** being the penal interest against the delay in transfer of 1st Instalment of Tied Grant under the 15th Finance Commission for the year 2022-23, is hereby released to 26 Zilla Parishad (Twenty Six) to be credited to their respective Bank Accounts as per allocation and Govt. of India Guidelines vide No.15(2)FC-XV/FCD/2020-25, dated 01-06-2020. The fund is released with the following conditions:-

1. The amount shall be utilized against the schemes selected by ZPs as per Govt. of India and Govt. of Assam's guidelines.
2. The ZPs shall utilize the fund as per guidelines of 15th Finance Commission and shall be responsible for any violation of the guidelines.
3. The ZPs shall submit the Utilization Certificates in prescribed **GFR-12 C** format duly countersigned by the CEO, Zilla Parishads concerned alongwith photographs of completion of the schemes to this Commissionerate in due course of time for onward submission to the Govt. for releasing next installments.
4. All the expenditure must be incurred in online mode through e-gram swaraj application.
5. All the procedure laid down at AFR condition and codal provisions of AFRBM Act, 2005 and CVC guidelines must be strictly followed.

5. The amount will be distributed to PRIs as per recommendation of FC.
6. The amount shall be drawn by commissioner, Panchayat & Rural Development and shall be disbursed to each of the PRIs in their accounts duly registered under PFMS and the amount shall be transferred through ECS.
7. PRI shall utilize the fund as per Guidelines of 15th FC and shall be responsible for any violation of the guidelines.
8. The overall responsibility for compliance of the guidelines shall continue to rest with the commissioner, Panchayat & Rural Development, Assam
9. UCs should be submitted in prescribed GFR-12C Format in due time.
