In Pursuance of Govt. in Panchayat & Rural Development Department sanction No.:FS/PRD_2021-22(I)_188, dated 23-03-2022 for Rs.122.34 Lakhs (Rupees One Crore Twenty Two Lakh Thirty Four Thousand only) being the penal interest against the delay in transfer of 2nd Instalment of Basic Grant (Untied) under the 15th Finance Commission for the year 2020-21, fund is hereby released to 26 Zilla Parishads (Twenty Six) to be credited to their respective Bank Accounts as per allocation and Govt. of India Guidelines vide No.15(2)FC-XV/FCD/2020-25, dated 01-06-2020. The fund is released with the following conditions:-

- The amount shall be utilized against the schemes selected by PRIs as per Govt. of India and Govt. of Assam's guidelines.
- 2. The PRIs shall utilize the fund as per guidelines of 15th Finance Commission and shall be responsible for any violation of the guidelines. .
- 3. The PRIs shall submit the Utilization Certificates in prescribed GFR-12 C format duly countersigned by the CEO, Zilla Parishads concerned alongwith photographs of completion of the schemes to this Commissionerate in due course of time for onward submission to the Govt. for releasing next installments.
- 4. All the expenditure must be incurred in online mode through e-gram swaraj application.
- All the procedure laid down at AFR condition and codal provisions of AFRBM Act,
 2005 and CVC guidelines must be strictly followed.
