**ORDER**

In Pursuance of Govt. in Panchayat & Rural Development Department sanction No.: FS/PRD\_2023-24(I) \_147 dated 06-12-2023 and FOC No. FIN/DIS/PRD/003/2023/1379, dated 31/01/2024 for an amount of **Rs.4655.25 Lakh (Rupees Forty-six crore Fifty Five Lakh Twenty Five Thousand only)** being the 1<sup>st</sup> Instalment of Basic Grant (Tied) under 15<sup>th</sup> Finance Commission for the year 2023-24, fund is hereby released to **27 (Twenty -Seven) Zilla Parishads** and to Sipajhar Municipality Board to be credited to their respective Bank Accounts as per allocation and Govt. of India Guidelines issued vide No.15(2)FC-XV/FCD/2020-25, dated 01-06-2020. The fund is released with the following conditions:-

1. The amount shall be utilized against the schemes selected by ZPs as per Govt. of India and Govt. of Assam's guidelines.
2. The ZPs shall utilize the fund as per guidelines of 15<sup>th</sup> Finance Commission and shall be responsible for any violation of the guidelines.
3. The ZPs shall utilize the fund for the O&M of PWSS handed over to PRI's viz. payment of remuneration of the Jal Mitras, electricity bills, expenses for chemicals etc, as required.
4. The ZPs shall utilize the fund for O&M of Assets created for Sanitation for maintaining ODF+ status, as required.
5. The ZPs shall submit the Utilization Certificates in prescribed GFR-12 CGFR-12 C format duly countersigned by the CEO, Zilla Parishads concerned alongwith photographs of completion of the schemes to this Commissionerate in due course of time for onward submission to the Govt. for releasing next instalments.
6. All the expenditure must be incurred on online mode through e-gram swaraj application.
7. All the procedure laid down at AFR condition and codal provisions of AFRBM Act, 2005 and CVC guidelines is to be strictly followed invariably.

7. PRI shall utilize the fund as per Guidelines of 15th FC and shall be responsible for any violation of the guidelines.
8. The overall responsibility for compliance of the guidelines shall continue to rest with the commissioner, Panchayat & Rural Development, Assam
9. UCs should be submitted in prescribed GFR-19A Format in due time.
