In Pursuance of Govt. in Panchayat & Rural Development Department sanction No.:FS/PRD_2021-22(I)_07, dated 19-05-2021 for **Rs. 2507.10000 Lakhs (Rupees Twenty Five Crore Seven Lakh Ten Thousand)** only being the 50% of the allocation of 2nd Instalment of Basic Grant (Untied) under 15th Finance Commission for the year 2020-21, fund is hereby released to 26 (Twenty Six) Zilla Panchayats, to be credited to their respective Bank Accounts as per allocation and Govt. of India Guidelines issued vide No.15(2)FC-XV/FCD/2020-25, dated 01-06-2020. The fund is released with the following conditions:-

1. The amount shall be utilized against the schemes selected by ZPs as per Govt. of India and Govt. of Assam's guidelines.
6. ZPs shall utilize the fund as per guidelines of 15th Finance Commission and shall be responsible for any violation of the guidelines. .
7. The ZPs shall submit the Utilization Certificates in prescribed **GFR-12 C** format duly countersigned by the CEO, Zilla Parishads concerned alongwith photographs of completion of the schemes to this Commissionerate in due course of time for onward submission to the Govt. for releasing next installments.
8. All the expenditure must be incurred in online mode through e-gram swaraj application.
9. All the procedure laid down at AFR condition and codal provisions of AFRBM Act, 2005 and CVC guidelines are to be strictly followed.
