In Pursuance of Govt. in Panchayat & Rural Development Department sanction No.: FS/PRD\_2022-23(I) \_03 dated 18-04-2022 for an amount of **Rs 2966.00 Lakh (Rupees Twenty Nine Crore Sixty-Six lakh only)** only being the 2nd Instalment of Basic Grant (Untied) under 15<sup>th</sup> Finance Commission for the year 2021-22, fund is hereby released to 26 (Twenty - Six) Zilla Parishads to be credited to their respective Bank Accounts as per allocation and Govt. of India Guidelines issued vide No.15(2)FC-XV/FCD/2020-25, dated 01-06-2020. 2. PRIs shall utilize the fund as per guidelines of 15<sup>th</sup> Finance Commission and shall be responsible for any violation of the guidelines.
3. The PRIs shall submit the Utilization Certificates in prescribed **GFR-12 C** format duly countersigned by the concerning CEO, Zilla Parishads alongwith photographs of completion of the schemes to this Commissionerate in due course of time for onward submission to the Govt. for releasing next installments.
4. All the expenditure must be incurred in online mode through e-gram swaraj application.
5. All the procedure laid down at AFR condition and codal provisions of AFRBM Act, 2005 and CVC guidelines is to be strictly followed invariably.
