

ORDER

In Pursuance of Govt. in Panchayat & Rural Development Department sanction No.: FS/PRD_2024-25(I) _13 dated 10-04-2024 and FOC No. FIN/DIS/PRD/003/2024/1482, dated 17/04/2024 for an amount of **Rs.4655.25 Lakh (Rupees Forty Six Crore Fifty Five Lakh Twenty Five Thousand only)** being the 2nd Instalment of Basic Grant (Tied) under 15th Finance Commission for the year 2023-24, fund is hereby released to **191 (One Hundred Ninety One) Anchalik Panchayats** and to Sipajhar Municipality Board to be credited to their respective Bank Accounts as per allocation and Govt. of India Guidelines issued vide No.15(2)FC-XV/FCD/2020-25, dated 01-06-2020. The fund is released with the following conditions:-

1. The amount shall be utilized against the schemes selected by APs as per Govt. of India and Govt. of Assam's guidelines.
2. The APs shall utilize the fund as per guidelines of 15th Finance Commission and shall be responsible for any violation of the guidelines.
3. The APs shall utilize the fund for the O&M of PWSS handed over to PRI's viz. payment of remuneration of the Jal Mitras, electricity bills, expenses for chemicals etc, as required.
4. The APs shall utilize the fund for O&M of Assets created for Sanitation for maintaining ODF+ status, as required.
5. The APs shall submit the Utilization Certificates in prescribed GFR-12 CGFR-12 C format duly countersigned by the CEO, Zilla Parishads concerned along with photographs of completion of the schemes to this Commissionerate in due course of time for onward submission to the Govt. for releasing next instalments.
6. All the expenditure must be incurred on online mode through e-gram swaraj application
7. All the procedure laid down at AFR condition and codal provisions of AFRBM Act, 2005 and CVC guidelines must be strictly followed invariably.
8. And as directed by Election commission of India, Model code of conduct is in force on account of General Elections of Lok Sabha, 2024 and to some Legislative Assemblies; therefore, the release of grant will be governed by the following conditions:-


- I. There shall be no publicity in this regard in electronic, print, radio, internet or any other media, in any form whatsoever.
- II. No political functionary shall make any reference in this regard during any public speech or communication to the press or public.
- III. These restrictions on publicity will be applicable to the Central Government as well as the State Governments concerned.
- IV. The relevant provisions of Model Code of Conduct (MCC) issued by the Commission shall be strictly followed.
- V. No new work shall be taken up afresh during MCC period.
