

**ORDER**

In Pursuance of Govt. in Panchayat & Rural Development Department sanction No.:FS/PRD\_2024-25(I)\_10, dated 10-04-2024 and FOC No. FIN/DIS/PRD/003/2024/1479, dated 17/04/2024 for an amount **Rs.3103.50 Lakhs (Rupees Thirty One Crore Three Lakh Fifty Thousand only)** being the 2<sup>nd</sup> Instalment of Basic Grant (Untied) under the 15<sup>th</sup> Finance Commission for the year 2023-24, fund is hereby released to **191 Anchalik Panchayats** (One Ninety One) to be credited to their respective Bank Accounts as per allocation and Govt. of India Guidelines vide No.15(2)FC-XV/FCD/2020-25, dated 01-06-2020. The fund is released with the following conditions.

1. The amount shall be utilized against the schemes selected by APs as per Govt. of India and Govt. of Assam's guidelines.
2. The APs shall utilize the fund as per guidelines of 15<sup>th</sup> Finance Commission and shall be responsible for any violation of the guidelines.
3. The APs shall submit the Utilization Certificates in prescribed **GFR-12 C** format duly countersigned by the CEO, Zilla Parishads concerned alongwith photographs of completion of the schemes to this Commissionerate in due course of time for onward submission to the Govt. for releasing next installments.
4. All the expenditure must be incurred in online mode through e-gram swaraj application.
5. All the procedure laid down at AFR condition and codal provisions of AFRBM Act, 2005 and CVC guidelines must be strictly followed.
6. And as directed by Election commission of India, Model code of conduct is in force on account of General Elections of Lok Sabha, 2024; therefore, the release of grant will be governed by the following conditions:-
  - i. There shall be no publicity in this regard in electronic, print, radio, internet or any other media, in any form whatsoever.
  - ii. No political functionary shall make any reference in this regard during any public speech or communication to the press or public.
  - iii. These restrictions on publicity will be applicable to the Central Government as well as the State Governments concerned.
  - iv. The relevant provisions of Model Code of Conduct (MCC) issued by the Commission shall be strictly followed.
  - v. No new work shall be taken up afresh during MCC period.
