In Pursuance of Govt. in Panchayat & Rural Development Department sanction No.: FS/PRD_2022-23(I) _66 dated 12-10-2022 for an amount of **Rs.3071.00 Lakh** (*Rupees Thirty Crore Seventy-one lakh Thousand only*) being the 1st Instalment of Basic Grant (Untied) under 15th Finance Commission for the year 2022-23, fund is hereby released to 27 (Twenty - Seven) Zilla Parishads to be credited to their respective Bank Accounts as per allocation and Govt. of India Guidelines issued vide No.15(2)FC-XV/FCD/2020-25, dated 01-06-2020. The fund is released with the following conditions:-

- 1. The amount shall be utilized against the schemes selected by PRIs as per Govt. of India and Govt. of Assam's guidelines.
- 2. PRIs shall utilize the fund as per guidelines of 15th Finance Commission and shall be responsible for any violation of the guidelines.
- 3. The PRIs shall submit the Utilization Certificates in prescribed **GFR-12** C format duly countersigned by the concerning CEO, Zilla Parishads alongwith photographs of completion of the schemes to this Commissionerate in due course of time for onward submission to the Govt. for releasing next installments.
- 4. All the expenditure must be incurred in online mode through e-gram swaraj application.
- 5. All the procedure laid down at AFR condition and codal provisions of AFRBM Act, 2005 and CVC guidelines is to be strictly followed invariably.

TERMS & CONDITIONS

- 1. All norms in Assam Financial Rules, AFRBM Act 2005, CVC Guidelines, Assam Public Procurement Act 2017, Assam Public Procurement Rules 2021 and similar directives from Finance Department issued from time to time is to be strictly followed invariably.
- 2. The admissible deductions can be deducted and deposited into the Govt. Account by the Concerned Authority as per rule/ Govt. Instructions.
- 3. Work to be completed within the estimated cost in all respect without involving cost and time over run.
- 4. The amount shall be utilized against the schemes selected by PRIs only as per Govt. of India and Govt. of Assam's guideline .
- 5. The amount will be distributed to PRIs as per recommendation of FC.
- The amount shall be drawn by commissioner, Panchayat & Rural Development and shall be disbursed to each of the PRIs in their accounts duly registered under PFMS and the amount shall be transferred through ECS.
- 7. PRI shall utilize the fund as per Guidelines of 15th FC and shall be responsible for any violation of the guidelines.
- 8. The overall responsibility for compliance of the guidelines shall continue to rest with the commissioner, Panchayat & Rural Development, Assam
- 9. UCs should be submitted in prescribed GFR-19A Format in due time.
