In Pursuance of Govt. in Panchayat & Rural Development Department sanction No.:FS/PRD\_2021-22(I)\_12, dated 19-05-2021 for **Rs.13841.04000 Lakhs (Rupees One Hundred and Thirty Eight Crore Forty One Lakh Four Thousand )** only being the 1<sup>st</sup> Instalment of Basic Grant (Untied) under 15<sup>th</sup> Finance Commission for the year 2021-22, fund is hereby released to 2197 (Two Thousand one hundred Ninety Seven) Gaon Panchayats, to be credited to their respective Bank Accounts as per allocation and Govt. of India Guidelines issued vide No.15(2)FC-XV/FCD/2020-25, dated 01-06-2020. The fund is released with the following conditions:-

1. The amount shall be utilized against the schemes selected by GPs as per Govt. of India and Govt. of Assam's guidelines.
2. GPs shall utilize the fund as per guidelines of 15<sup>th</sup> Finance Commission and shall be responsible for any violation of the guidelines. .
3. The GPs shall submit the Utilization Certificates in prescribed **GFR-12 C** format duly countersigned by the CEO, Zilla Parishads concerned alongwith photographs of completion of the schemes to this Commissionerate in due course of time for onward submission to the Govt. for releasing next installments.
4. All the expenditure must be incurred in online mode through e-gram swaraj application.
5. All the procedure laid down at AFR condition and codal provisions of AFRBM Act, 2005 and CVC guidelines are to be strictly followed.
