In Pursuance of Govt. in Panchayat& Rural Development Department sanction No.:FS/PRD_2020-21(I)_44,dated 11-11-2020 for **Rs.23399.60000 Lakhs (Rupees Two Hundred and Thirty Three Crore Ninety Nine Lakh Sixty Thousand only)** being the 1st Instalment of Basic Grant (Untied) under 15th Finance Commission for the year 2020-21, fund is hereby released to the 2197 Gaon Panchayats (Two Thousand One Hundred Ninety Seven) to their respective Bank Accounts as per allocation and Govt. of India Guidelines vide No.15(2)FC-XV/FCD/2020-25, dated 01-06-2020. The fund is released with the following conditions:-

1. The amount shall be utilized against the schemes selected by GPs as per Govt. of India and Govt. of Assam's guidelines.
2. GPs shall utilize the fund as per guidelines of 15th Finance Commission and shall be responsible for any violation of the guidelines. .
3. The GPs shall submit the Utilization Certificates in prescribed **GFR-12 C** format duly countersigned by the CEO, Zilla Parishad concerned along with photographs of completion of the schemes to this Commissionerate in due course of time for onward submission to the Govt. for releasing next installments.
4. All the expenditure must be incurred in online mode through e-GramSwaraj application.
5. All the procedure laid down at AFR condition and codal provisions of AFRBM Act, 2005 and CVC guidelines are to be strictly followed.
