**ORDER**

Dated: Guwahati, the 5<sup>th</sup> October' 2020

In Pursuance of Govt. in Panchayat & Rural Development Department sanction No.:FS/PRD\_2020-21(I)\_29, dated 18-07-2020 for **Rs.5014.20000 Lakhs (Rupees Fifty Crore Fourteen Lakh Twenty Thousand)** only being the 1<sup>st</sup> Instalment of Basic Grant (tied) under 15<sup>th</sup> Finance Commission relating to the year 2020-21, fund is hereby released to the 26 Zilla Parishads (Twenty Six) through their respective Bank Accounts as per allocation and Govt. of India Guidelines vide No.15(2)FC-XV/FCD/2020-25, dated 01-06-2020 and with the following conditions:-

1. The amount shall be utilized against the schemes selected by PRIs as per Govt. of India and Govt. of Assam's guidelines.
2. PRIs shall utilize the fund as per guidelines of 15<sup>th</sup> Finance Commission and shall be responsible for any violation of the guidelines. .
3. The PRIs shall submit the Utilization Certificates in prescribed **GFR-12 C** format duly countersigned by the concerning CEO, Zilla Parishads along with photographs of completion of the schemes to this Commissionerate in due course of time for onward submission to the Govt. for releasing next installments.
4. All the expenditure must be incurred in online mode through e-gram swaraj application.
5. All the procedure laid down at AFR condition and codal provisions of AFRBM Act, 2005 and CVC guidelines is to be strictly followed invariably.

Note: Comprehensive guidelines for implementation of 15<sup>th</sup> FC Grant will be issued shortly.  
Till then no fund is to be utilized.
