(1) Minimum educational qualification is H.S.L.C. Examination passed or equivalent from a recognised Board/ Council of Government of Assam.

(2) A candidate must possess a valid professional Driving License preferably LMV category.

Age: Must not be less than 18 years and more than 40 (forty) years as on 01.01.2021. Upper age limit is relaxable by 3 (three) years for OBC/MOBC and 5 (five) years for SC/ST candidates. The age limit of the candidates will be calculated on the basis of the Matriculation/HSLC Admit Card/Certificate issued by a recognized Board / Council and no other document shall be accepted in lieu thereof for the purpose.

Application fees: Nil.

Mode of Selection:

A candidate have to appear in the following examination for selection.

Phase-I: Candidates whose applications are accepted will be required to appear in the Written Test on Driving knowledge on Traffic Rules & Traffic Signals to be held at Dist. Head Quarter of Biswanath, Charaideo, Hojai, Majuli & South Salmara Dist. on the date to be notified later on. The Driving knowledge on Traffic Rules & Traffic Signals will be of 100 marks.

Phase-II: Against each vacancy four candidates will be short listed on the basis of the marks obtained in the Written Test on Driving knowledge on Traffic Rules & Traffic Signals. The short-listed candidates will have to appear along with all original testimonials in the Driving Skill Test to be held at Dist. Headquarter of Biswanath, Charaideo, Hojai, Majuli &, South Salmara Dist. to be notified later on. The Driving Skill Test will be of 100 marks.

CANDIDATES ARE REQUIRED TO APPLY IN PRESCRIBED FORM THROUGH ONLINE MODE ONLY. NO OTHER MODE FOR SUBMISSION OF APPLICATION IS ALLOWED.

No other document i.e. the hard copy of the online application form registration slip etc. are required to be sent to the office of the Commissioner, Panchayat & Rural Development, Assam, Juripar, Panjabari, Guwahati-37.

Detail instruction for uploading the online application form and other terms & Conditions for the posts of Driver:

The Candidates having the required qualification for Driver posts as mentioned Advertisement may apply for the post. Candidates will require to upload scanned copies of the following:-

(1)

a) Passport Size Photograph: -

Please pay attention to upload good quality photograph. Poor quality photograph submitted will lead to rejection of application. The Admit card will be printed with the uploaded photograph.

i) The photograph must be in colour and must be taken in a professional studio. Photograph taken by a mobile phone and other self-composed portraits are not acceptable.

ii) Photograph must be taken in a white background.

iii) The photograph must have been taken after 1stJanuary, 2021.

iv) Face should occupy about 50% of the area in the photograph, and with a fullface view looking into the camera directly.

- v) The main features of the face must not be covered by hair of the head, any cloth or any shadow. Forehead, both eyes, nose, cheeks, lips and chin should be clearly visible.
- vi) If someone normally wear spectacles, glare on glasses is not acceptable in his photo. Glare can be avoided with a slight downward tilt of the glasses for the photo shoot.
- vii) Candidate must not wear spectacles with dark or tinted glasses, only clear glasses are permitted.
- Ask the photo studio to provide the image in a JPEG format and also on a standard 4.5cm x 3.5cm (45mm x 35mm) print.
- ix) Maximum pixel resolution for JPEG: 640 x 480 (0.3 Mega Pixel) (Ask the studio to reduce it to this resolution if it is higher).
 - Minimum pixel resolution for JPEG: 320 x 240.
 - xi) The maximum file size is 450 kb (kilo bytes).
